❖ Staff Report <ul style="list-style-type: none"> <li>Deacon Ramón is leaving his half time position at St. Odilia in order to become full time at St. Stephan's in Anoka. Work had begun to find a replacement.</li> <li>This year's Easter candle arrived on March 16 and has a design similar to the St. Odilia "shattered" cross.</li> <li>Plans for the Easter liturgies are complete. On Holy Thursday there will be an English service in the church and a Spanish service in the gym and everyone will join in the Courtyard for adoration. There will also be separate Good Friday services in English and Spanish. On Good Friday the Prayers of the Faithful will be presented in multiple languages with English translations on the projection screens.
